



## 2019-2020 Title IX Annual Report

### California State University Maritime Academy

This annual report presents information about complaints of Sexual Misconduct, Dating and Domestic Violence, and Stalking reports brought to the attention of the Title IX Coordinator within the reporting period of July 1, 2019 through June 30, 2020 and the actions taken by the University to address those complaints.

Working closely with our campus partners, the University has taken an integrated approach to effectively address Sexual Misconduct, Dating and Domestic Violence, and Stalking issues involving students, faculty, staff and others covered under [CSU Executive Order 1095: Implementation of Title IX, VAWA/Campus SaVE Act, and Related Sex Discrimination, Sexual Harassment and Sexual Violence Legislation](#).

This report differs from the University's Annual Security and Fire Safety Report (Clery Report) for various reasons. Complaints made to the Title IX Coordinator may have occurred away from Clery defined geography, therefore the statistics in this report, which take into account all reports regardless of geography, will be different than the statistics in the Clery Report. In addition, this report is based on fiscal year (July – June) whereas the Clery Report is based on calendar year (January – December).
