• President's Introduction

 Actively participating in CSU Capitol Hill Days, EAB Enrollment Conference, Sail-In Days

• Opt-In Corps

- AA led by executive dean effective June 1, search firm secured, search committee will be formed
- o Associate VP Benton will retain duties with different title
- o Current school/dean model will remain
- o Provost, deans have been exploring other models
- Student Affairs will be led by dean effective upon VP Hellwig's departure search firm secured, search committee will be formed
- Also searching for director to lead admissions team
- Looking at changes to office of finance
- AVP for HR has changed to HR officer
- o Eliminated VP for advancement
- o Institution is over-administered
- o Changing from provost and VP saves about 40K
- Ensured that these roles will still participate in appropriate councils

Shared Services

- o Parts of HR (payroll), need a couple folks on the ground still
- Website design and management, currently in a contract with a company that only services one other CSU
- Our contract is up in a month, to find another company would be 300-400K
- Instead of globbing on to other CSU with the same company, want to glob on to another...will be offering 100K to another vendor to include us on their contract
- Senator Isakson mentions ability to write legislation, ASCSU
- Search for Executive Dean, Director of Cadet Leadership & Development
 - President tried to get a break from firms to run the two searches, but no such luck
 - Will be going with a boutique firm that the CSU often uses, who does not send a vetted list, but rather the entire list, and does not come to campus to run search

- Senator Holden mentions perceptions/optics about summer searches
- President responds with tight timeline, cannot post jobs until resignations are in hands
- Senator Holden suggests language to get ahead of these optics, particularly for cruise faculty
- Senator Ward discusses that MT faculty will likely not react as they have in the past

Other Organizational Updates

- What will happen to current dean of students? Considered changing to associate dean, but student affairs is much different than dean of students
- Commandants' office changes? Been floating other titles, getting feedback, 'commandant' doesn't work well for resumes in the future
 - Gone with Director of Cadet Leadership and Development, and whoever we find will craft this role
- o Senator Senk suggests leading email with "this institution is over-administered"
 - o Senator Isakson mentions that this is a CSU-wide problem
- 0 712 students this morning
- Library Dean? Executive Dean will work on crafting restructure, and Provost Schroeder has communicated restructure in the meantime

Commandants

- Senator Ward has observed a lot of failures in this system, such as not managing watch, not keeping track of students going to formation
- What makes sense for us going forward? What makes sense for CA?
- o Senator Ward suggests including maritime folks in the restructure, if redundancy
- Senator Simons reports the operations of the corps of cadets under the commandants' office has been antagonistic against education – routinely contacting about watch conflicting with class, and am told "we are working on this" and students consistently report that they have to go to watch
- Faculty get worked up over Commandants' Office lack of assessment, plan, knowledge of how to do this in Cadet Leadership and Development,
- Senator Senk reports lack of consistency it's nice that they've tried to be more lenient, but it backfired. Faculty want consistency in enforcement, etc.
- President: plan for new role is that of PD, to explain reason for having the Corps of Cadets (safety, demerit system required
- List on my desk of 63 students with 320 demerits (75 is the "limit")
- At Harbor Cup, students were verbally toting their large number of demerits, in front of alumni "ah, Cal Maritime, where we set low standards for ourselves and fail to achieve them"

- Got an email forwarded from a faculty saying that commandants are at the dining center starving students (not letting them eat) these misleading types of rhetoric are damaging
- o Been a corrective body, rather than a leadership, role model body
- State maritime academy governing body says to be on the training ship as a person under instruction, must be in Corps of Cadets
- o To get CG license, must be in Corps of Cadets
- If required by major, students may have to be in Corps of Cadets for first year, or second year, etc. (examples in non-license engineering)
- SUNY told us two biggest mistakes around opt-in: didn't roll out well (no socializing, website etc.), very sharp cadet next to a student wearing PJs and reeking
- o CSU lawyers are fighting president on standardized dress code
- o Khakis, polo, long-sleeve polo, jacket, fluffy vest, all embroidered
- o Who will enforce? Dean of Students
- This dress code is similar to that of private schools perhaps that rhetoric would be useful a private experience for public institution costs
- Easier to do this incrementally than a free-for-all
- Senator Ward recommends that Corps become stricter written up in the moment and handed a slip, and provide allowances for entry level classes
- Uniforms will be strictly adhered to on the ship, cadets who do not show up in appropriate attire or do not show up on time...let off at next port
