RTP Workshop for RTP candidates eligible for retention, tenure and/or promotion and candidates applying for early tenure and/or promotion	Thurs 14 April
Senate Chair convenes the Senate RTP Committee to elect its chair. Department Chairs administer the election of Department RTP Committees.	Fri 2 Sept
